Page 5 of Section-1, Para 1.7 (iv) should read as

Technical Capacity requirements are as follows: -

- a) The Bidder must have been engaged in sale of Waste/scrap Paper for five years' experience of performing similar kind of job from any Government press or Government Undertaking Press.
- b) A bidder must have the capacity to lift the waste/scrap paper for collection, packing and loading of waste/scrap paper within press premises on regular basis at his own cost.
- c) The bidder must have the certificate of enlistment under PF & ESIC act.
- d) The bidder must submit the last month (January,2024) payment challan of PF & ESIC of at least 10 labours.
- e) Bidders who have past history of non-performing of similar contracts at West Bengal Text Book Corporation Ltd or its Parent Company Saraswati Press Ltd would be ineligible to participate in the Bid.

Page 13 of Section-2, Para 2.4.1 should read as

Eligible Bidders	2.4.1	Eligible and qualified genuine paper waste/scrap buyers/Paper Mills may participate in the bid. The prospective bidders shall have to meet the following eligibility criteria: (a) The Bidder must have been engaged in purchase of Waste/scrap Paper for 5 (five) years i.e (2018-2019, 2019-2020, 2020-2021, 2021-2022 & 2022-2023)

from any Government Press or Government Undertaking Press.

- (b) A bidder must have the capacity to lift the waste/scrap paper & materials for collection, packing and loading of waste/scrap within press premises on regular basis at your own cost.
- (c) A capable genuine paper waste/scrap buyer shall have minimum annual turnover of Rs.3 Crores in any of the last three financial years (i.e. 2020-2021, 2021-2022 & 2022-2023) from sale of Waste/Scrap paper.
- (d) Eligible Paper Mills shall have minimum average turnover of Rs 50 crores for the three Financial Year i.e.(2020-2021 ,2021-2022 & 2022-2023).
- (e) The bidder must submit the last month (January,2024) payment challan of PF & ESIC of at least 10 labours.
- (f) Bidders who have past history of non-performing of similar contracts at West Bengal Text Book Corporation Ltd or its Parent Company Saraswaty Press Ltd would be ineligible to participate in the Bid.

Page 19 of Section-2, Para 2.11.2 should read as

- (ii) Documents to support that the Bidder is in Waste/scrap paper sale business or Paper Manufacturer for the 5 (five) financial years (2018-19, 2019-2020, 2020-2021, 2021-2022 & 2022-2023).
- (iii) Letter of Financial Bid.
- (iv) Copy of proof of electronic fund transfer towards Earnest Money Deposit (EMD)/ Bid Security as prescribed in the e-NIT

- (v) Notice Inviting e-Tender (Section-1) and Instructions to Bidders (Section-2) (uploaded with digital signature).
- (vi) General Conditions of Purchase (Section – 4).
- (vii) Documents to support that the Bidder must have experience to collect, packing and lifting waste/scrap paper & materials in sellers premises.
- (viii) Copy of last month payment challan of PF & ESIC of at least 10 labours.
- (ix) Bidders who have past history of non-performing of similar contracts at West Bengal Text Book Corporation Ltd or its Parent Company Saraswaty Press Ltd would be ineligible to participate in the Bid.
